10. Administrative Board should follow the Aided procedures.
11. Fixed Deposit of Rs.10,000-00 for 1st Standard to 4th standard and Rs.20,000/- for Highschool students 5th standards to 7th standard should be made in the Joint name of Block Education Officer, as per the Education Act 1983 (50% for SC & ST Students)
12. To open the Service Register of Staffs.
